Crop Water Use Report for the week of July 12th, 2021.

This is Erin Lee with the UNWNRD and this is the Crop Water Use Report for the week of July 12th, 2021.

Over the past week, wheat used 0.19 inches.
Expected use by wheat for this week is 0.20 inches.

Over the past week, corn used 0.97 inches.
Expected use by corn for this week is 1.07 inches.

Over the past week, beets used 0.65 inches.
Expected use by beets for this week is 0.71 inches.

Over the past week, potatoes used 1.73 inches.
Expected use by potatoes for this week is 1.82 inches.

Over the past week, dry beans used 0.91 inches.
Expected use by dry beans for this week is 0.96 inches.

Over the past week, soybeans used 1.14 inches.
Expected use by soybeans for this week is 1.20 inches.

Over the past week, sunflowers used 0.19 inches.
Expected use by sunflowers for this week is 0.20 inches.

Over the past week, alfalfa used 1.90 inches.
Expected use by alfalfa for this week is 2 inches.

Over past week, actively growing lawns used 1.8 inches.
Expected use by actively growing lawns for this week 2.00 inches.

In the past week average ET gauge readings were 1.90 inches.

The average rainfall for the district was 0.62 inches.

The weather forecast for the next week shows highs ranging from the low 80s to low 90s, and lows in the 50s and 60s. It will be mostly sunny and hot with chances of thunderstorms early and into the middle of the week, then again towards the end of the week.

In the last week, soil moisture monitoring station 2 showed 48% water available at 12", 67% water available at 24", and 78% water available at 36". The producer did irrigate. Remember this is in a **Loam** soil type with **Beets** planted and will vary depending on site, weather, irrigation management, topography, crop, and soil type.

The crop water use report is completed using the average growth stage for each crop and ET gauge reading from across the district. To find the conversion for your specific crop growth stage, visit <https://nawmn.unl.edu/GrowthStageData>.
